### TAX INCREMENT FINANCING DISTRICT 7-1

The City Administrator reviewed the proposed Tax Increment Financing District 7-1 and its related Development District program. He noted this district contains two non-contiguous areas. One is along Rice Street containing the properties at 2724, 2736, 2744, 2750, 2760, and 2768 Rice Street. This are will capture the Suite Living project to be constructed on 2736 & 2744 Rice. The other is along Little Canada Road and consists of 61, 75, and 93 Little Canada Road addresses. The primary focus for this area is the 93 West building and consideration of a future Town Square/Downtown.

There was discussion regarding the impact the creation of this TIF District would have on the property taxes of the included parcels. The City Administrator explained that there is no change as to how taxes are calculated for those parcels. However, their tax statements may show a "Tax Increment" line but that is just done for allocation purposes and is not impacting the overall tax calculation.

The City Administrator discussed the need for redevelopment of certain areas within the City and the recent discuss we had as part of the 2040 Comp Plan update.

The Commission asked about the TIF projections for the Suite Living project. The City Administrator said he would look that up and e-mail it out to the Commission. (Note: The estimated amount is \$53,759.)

Johnson moved adoption of the resolution finding that a Development Program for Development District No. 7 and a Tax Increment Financing Plan for Tax Increment Financing District No. 7-1 Conforms to the General Plans for the Development and Redevelopment of the City.

That motion was seconded by Kulousek. Motion carried 5-0.

Kwapick moved and Johnson seconded a motion to adjourn. The motion carried 5-0.
